Purpose of the Initiative:

- To evaluate the impact of:
 - *Policies*
 - *Programs*
 - *Practices*

- Addressing various types of substances:
 - *Alcohol Use*
 - *Illicit Drug Use*
 - *Tobacco Use*

- At various levels:
 - *State*
 - *School*
 - *Community*
 - *Individual*

A Collaborative Effort that Integrates Across:

- Multiple substances
- Multiple disciplines
- Multiple centers and collaborators
- Multiple levels of social organization
 - Multiple data sources



Structure of the Samples

- Half-sample of MTF schools cycling out of the national sample
 - c. 215 schools per year
 - National replicate sample
- Administrators in those schools surveyed
- Community data collected from their catchment areas
 - Observational studies of retail outlets
 - Key informant interviews in the community
 - Other existing archival data
- State legislative and other data are collected on all states

Evaluating Natural Experiments

- At any of three levels of social organization:
State, Community, and School
- Comparison data from MTF national samples
(grades 8, 10, & 12)
- Type of design
 - Cross-sectional analyses
 - Repeated cross-sectional analyses
 - Before-after change in school panels
- Occasionally supplementary school samples:
Rapid Response
 - Life Skills Training (LST) Evaluation
 - Alcohol Hotline Evaluation
